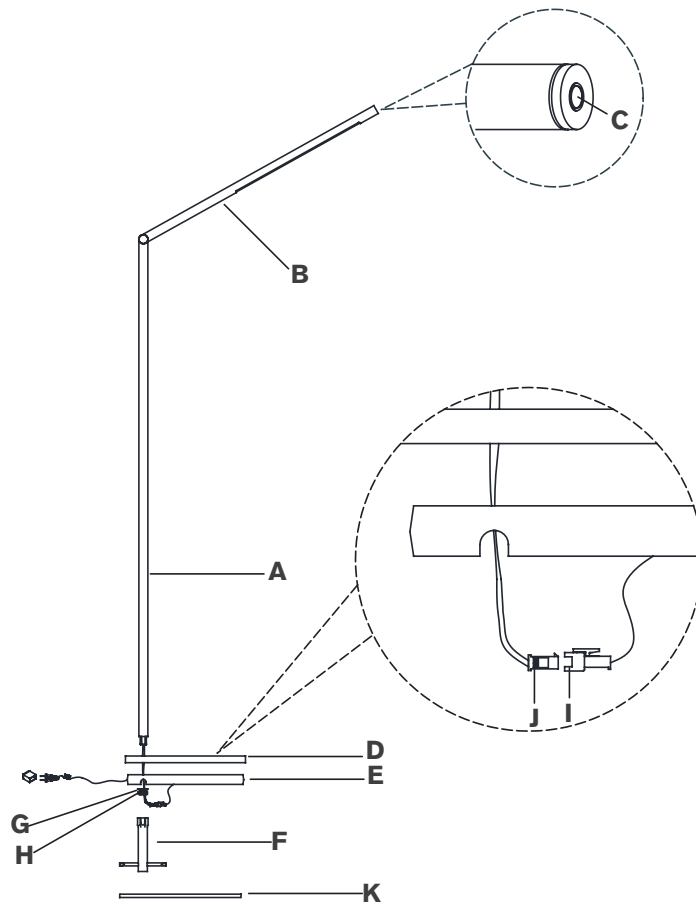

LED module is replaceable.

WARNINGS

All wires are connected. When unpacking, be careful not to pull wires, as damage may result. Do not connect electricity until lamp is fully assembled. To reduce the risk of fire, electrical shock, or personal injury, always turn off lamp and allow it to cool prior to replacing the LED. Do not touch or look directly at the LED when lamp is illuminated. Keep flammable materials away from lit LED.

ASSEMBLY AND INSTALLATION

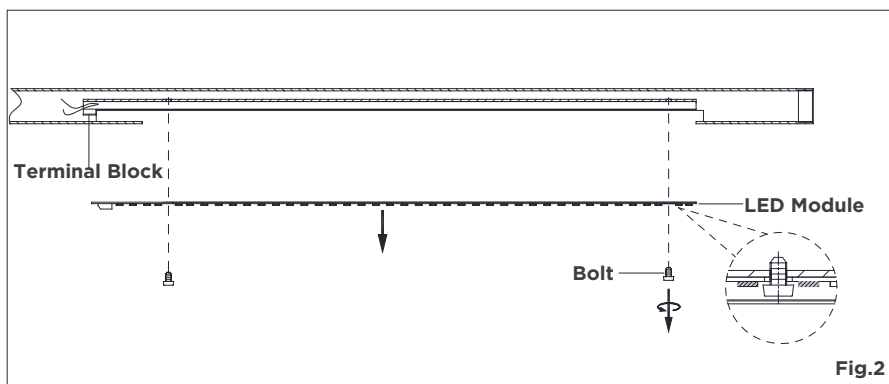
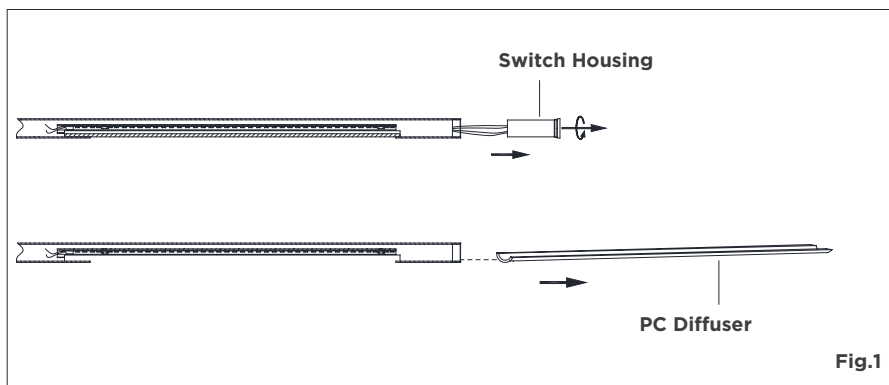
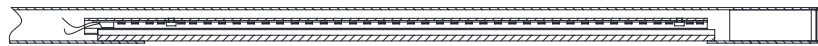
1. Carefully remove all parts from the box and remove all plastic coverings.
2. Insert Rod (A) through Lamp Base (D) and Loader (E). Secure with Washer (G) and Hex Nut (H) using Wrench (F).
3. Connect Female Quick Connector (I) to Male Quick Connector (J).
4. Remove adhesive backing from Felt Pad (K), and neatly apply to the bottom of Loader (E).
5. Dimmer switch operation: Touch Dimmer (C) to adjust between high, medium, low and off settings.
6. Adjust Lamp Arm (B) to the desired angle.
7. Plug into electrical outlet and test lamp.
8. Assembly is complete.

CARE INSTRUCTIONS

Do not use polishes or cleaners on the lamp. Wipe clean with a soft, dry cloth.

LED MODULE REPLACEMENT INSTRUCTION

1. Place the complete shade, with LED module inside, on a soft and clean surface.
2. Unscrew the switch housing by turning counterclockwise, and then pull it out from the shade. (Fig.1)
3. Carefully push the PC diffuser out by hand. (Fig.1)
4. Remove the LED module from the shade by unscrewing both bolts. (Fig.2)
5. Pull out the lamp's Neutral/Hot wires from the terminal block.
6. Put some thermal conductive silicone onto the backside of the new LED module, and insert the lamp's wires into the corresponding hole on the terminal block.
7. Reattach the LED module and PC diffuser to the shade. Test the lamp.
