

The LED module on this lamp is replaceable.

## WARNINGS

All wires are connected. When unpacking, be careful not to pull wires, as damage may result. Do not connect electricity until the lamp is fully assembled. To reduce the risk of fire, electrical shock, or personal injury, always turn off the lamp and allow it to cool prior to replacing the LED tape. Do not touch or look directly at the LED tape when the lamp is illuminated. Keep flammable materials away from lit LED tape.

## WARNING: STRANGULATION HAZARD

#### ASSEMBLY AND INSTALLATION

- Carefully remove all parts from the box and remove all plastic coverings.
- Join Lamp Pole (A) and Lamp Base (B) together, then slide Washer (C) over the threaded tip protruding through the bottom of Lamp Base (B).
- Screw Hex Nut (D) onto the threaded tip, and tighten using T-Wrench (E).
- 4. Pull the lamp wire until tight.
- Loosen Collar (F) to adjust Upper Pole (G) to the desired height, then tighten Collar (F).
- 6. Remove the plastic cover from the electrical plug.
- 7. Plug the lamp into a proper electrical outlet and test the lamp.
- 8. Assembly is complete.

#### CARE INSTRUCTIONS

Do not use polishes or cleaners on the lamp.

Wipe clean with a soft, dry cloth.






# LED TAPE REPLACEMENT INSTRUCTIONS

## PLEASE NOTE THAT THE LED REPLACEMENT MUST ONLY BE PERFORMED BY A LICENSED ELECTRICIAN

- Place the complete shade with LED module inside on a soft, clean surface.
- 2. Remove the PC diffuser from the shade by unscrewing the bolt using a screwdriver (Figure 1).
- Remove the LED module and washers from the shade by unscrewing the hex nuts and washers using a screwdriver (Figure 2).
- 4. Pull out the lamp Neutral/Hot wires from the terminal block.
- Place some thermal conductive silicone onto the backside of the new LED module. Insert the lamp wires into the corresponding hole on the terminal block.
- Replace the LED module and PC diffuser to the shade.
  Test the lamp.
